Oesterlen Parenting Group Childcare and Transportation Policy

Oesterlen offers transportation to and from the Parenting Group as well as childcare in Oesterlen's Respite Resource Center on campus during the Parenting Group. In order to allocate resources and meet the needs of those participating in the Parenting Group, Oesterlen requires notice no later than 4:00pm the day prior to the group to provide transportation or childcare. Transportation and childcare will be allocated on a first-come, first-served basis. If an individual is not able to attend the parenting group due to Oesterlen's capacity for childcare or transportation being filled at the time of their request at least 24 hours prior to the group, this will not be considered a "no-show" as in the policy above.
